Music

At St Matthew's we believe that Music stimulates creativity and imagination, providing a unique way of understanding and responding to the world. It enables children to communicate what they see, hear and experience. Music reflects the culture and society we live in as well as cultures from around the world.

We provide many opportunities for all children to create, play and perform musically. We develop skills necessary to appreciate a wide-range of Music. The appreciation and enjoyment of Music enriches all our lives, developing children's creativity, self-esteem and confidence.

# Aims and Objectives

- To improve the children's ability to play instruments and develop their vocal techniques.
- To know and understand how music is made through a variety of instruments and that it can be composed and written down.
- To develop the inter-related skills of performing and composing within Music.
- To develop an understanding of the inter-related dimensions of Music.
- To develop increasing confidence in Music.
- To foster an enjoyment and appreciation for Music and a knowledge of performers.
- To develop an understanding of the History of Music.
- To develop their improvisation and compositional skills.
- To listen and appraise a wide range of live and recorded music.

# Teaching and Learning styles

Music is taught through a mixture of whole class teaching and individual/group activities. Our peripatetic Music teacher, Miss Smith, draws attention to good examples of individual performance as models for the other children. We give children the opportunity within lessons to work on their own and collaborate with others. We encourage children to participate in a variety of musical experiences through which we aim to build up the confidence of all children.

We recognise the fact that we have children of differing ability in all our classes, and so we provide suitable learning opportunities for all children by matching the challenge of the task to the ability of the child. We achieve this through a range of strategies:

- Setting tasks that are open-ended and can have a variety of responses.
- Setting tasks of increasing difficulty where not all children complete all tasks.
- Providing a range of challenges with different resources.

# Arts Planning

The Music Lead and specialist Music teacher have created a unique scheme of work based on National Curriculum objectives. While there are opportunities for the children's abilities to develop their knowledge and skills in each teaching unit, the planned progression built into the scheme of work allows children to be increasingly challenged as they progress through the school, whilst our spiral curriculum creates the opportunity for consolidating knowledge and understanding.

Music is planned in two phases [long-term, medium/short-term]. The long-term plan maps the topics studied in each term during the key stage. The medium term plans are planned by the specialist Music teacher. The Music Lead is responsible for monitoring and reviewing these plans.

Class teachers and the specialist Music teacher assess children against lesson objectives and formally assess children at the end of each unit.

#### Music in the Curriculum

# **EYFS**

Children in Reception have weekly Music lessons with our specialist Music teacher. We relate the musical development of the children to the objectives set out in the Early Learning Goals, which underpin the curriculum planning for children aged three to five. The range of musical experiences encourages children to make connections between one area of learning and another and so extends their understanding.

# Extra-Curricular Music

Children in KS2 have the opportunity to join our school choir and school band run by the specialist Music teacher and Music Lead.

#### 1:1 Music Tuition/Music Therapy

Our specialist Music teacher runs 1:1 sessions with LAC children and those with emotional needs who benefit from Music as a form of therapy and creative expression to boost confidence and develop a safe space for vulnerable children.

#### Cross-Curricular Links

Cross-curricular links are made through careful whole school planning and liaison between subject leaders.

#### **English**

Music contributes to the teaching of English by inspiring story-telling and lyrical composition such as the Year 3 topic *The Enormous Crocodile* and the Year 1 topic I Like the Flowers.

#### Mathematics

Music contributes to the teaching of mathematics through the understanding of rhythm and pulse, musical structure and time signatures.

# Philosophy for Children

Music can be used as an inspiration point for philosophical discussion at the start of Foundation subjects.

# **History**

Children develop an understanding of the History of Music throughout the Music curriculum.

# Personal, social and health education and citizenship

Through making music, children learn to work more effectively with other people and build upon good relationships. Music is the basis of many social activities and has an important role to play in the personal development of children.

# Spiritual, moral, social and cultural diversity

Listening, creating and performing in Music can be a moving and even spiritual experience. We encourage children to reflect on the important effect that Music has on people's moods, senses and quality of life. Children at St. Matthew's have the opportunity to encounter Music from many cultures and through a growing knowledge and understanding of a range of Music, they develop more positive attitudes towards other cultures and societies.

#### Inclusion and Equal Opportunities

All teaching and non-teaching staff at St. Matthew's Catholic are responsible for ensuring that every pupil, regardless of gender, race, culture, background and ability have the opportunity to experience arts education at an appropriate and challenging level. To ensure that children experience high standards of success, creative development needs to be taught with regards to children's abilities to ensure progress. We aim to identify and minimise barriers to learning and take account of gender, ability, disability, social, cultural, and linguistic background when planning lessons. Provision is made to enable all pupils to participate effectively in curriculum and assessment activities.

Whatever the manner of class organisation, we try to ensure that no child adopts a passive role in Music at St. Matthews.

Music can provide the opportunity for new pupils with limited English to achieve and can therefore raise their self-esteem. It is a subject into which newly arrived pupils can easily be integrated. Music can encourage the development of a wide range of social skills through collaborative working and sharing of ideas. Through Music they learn to express themselves non-verbally and may, in this context, be able to contribute cultural knowledge and experience that is of benefit to all pupils.

# Accessibility and Teaching Music to children with Special Educational Needs

We teach Music to all children, whatever their ability, in accordance with the school curriculum policy of providing a broad balanced education to all. Teachers provide learning opportunities matched to the needs of children with learning difficulties, taking into account the targets set for individual children in their individual educational plans.

#### Arts Award

Those children in Choir and School Band will be given the opportunity to work towards achieving Arts Award, which will be supported through their weekly choir and band rehearsals, participation in the Peace Proms concert and through visits and enrichment opportunities such as concerts at the Royal Liverpool Philharmonic Hall.

#### Assessment and Recording

The specialist Music teacher assesses children's work through formative assessment during lessons and by end of unit recordings. At the end of each unit of work, the specialist Music teacher makes a summary judgement about the work of each pupil, recording it termly on assessment trackers.

#### Resources

We keep resources for Music in central stores in the school hall. The Music Lead is responsible for these resources.

#### Monitoring and review

The Music Lead is responsible for the standard of children's work and for the quality of teaching and they monitor this through lesson observations, planning scrutiny and regular meetings with the specialist Music teacher. The Music Lead is also responsible for completing termly action plans to strengthen and develop their subject.

# Working with Professional Artists and Arts Organisations
