AFTERSCHOOL CLUB

We are delighted to have begun our own provision for After School Club from 3:15 pm - 6:00 pm every day.

The cost of this provision is £12 per day. For Weekly bookings there is a discounted rate of £55.

For siblings, we also offer a discount please contact Mrs Murray in the school office for details.

The price includes snacks and activities for the children.

We are registered on the Government Tax-Free system which means you can pay via your online Government Account and receive 20% back.

Illustration:

If your child attends 5 days per week. The cost is £220 per month. With the Tax-Free Childcare this is reduced to £176.00. Meaning every 4th month is free.

BREAKFAST CLUB

- ♦ We have a daily breakfast club from 7:45am - 8:40am each morning.
- ♦ Children are given a wide selection of breakfast items, including, Cereal, Toast, Fruit, Yogurts and lots of other items.
- ♦ There are a variety of activities for the children to choose from.
- ♦ The cost is £3.00 per day and we ask that families pay one month ahead.
- ♦ The cost of this can also be paid via the Tax-Free account.

Illustration:

If your child attends 5 days per week the cost is £60 per month. With the Tax-Free childcare this is reduced to £48. Meaning every 4th month is free.



TAX-FREE CHILDCARE

Eligibility:

Your eligibility depends on:

- ♦ whether you're working (employed, self-employed, or a director)
- ♦ your income (and your partner's income, if you have one)
- ♦ your child's age and circumstances
- ♦ your immigration status

if you're working:

You can usually get Tax-Free Childcare if you (and your partner, if you have one) are:

- ♦ in work
- ♦ on sick leave or annual leave
- ♦ on shared parental, maternity, paternity or adoption leave and you're going back to work within 31 days of the date you first applied

If you're not currently working:

You may still be eligible if your partner is working and you get any of the following:

- ♦ Incapacity Benefit
- ♦ Severe Disablement Allowance
- ♦ Carer's Allowance or (in Scotland only) Carer Support Payment
- ♦ contribution-based Employment and Support Allowance

You can apply if you're starting or re-starting work within the next 31 days.

HOW TO IDENTIFY A TAX-FREE CHILDCARE PAYMENT

When a parent pays you using their childcare account, the transaction will appear on your bank statement as **National Savings A**.

This entry should also contain the child's:

- ♦ **Childcare reference number**, made up of 4 letters and 5 numbers. The letters are the first initial and the first 3 letters of the child's surname. For example, AJON12345.
- ♦ **Tax-Free Childcare account number**. This will be 13 digits long and start with 1100, and should contain the letters TFC. For example, TFC 1100012345678.

If your bank displays payment information differently and you are unable to identify a parent's payment, you can submit a **payment reconciliation form** or call the childcare service helpline: 0300 123 4097.
